

HUSKY TIRE LIMITED WARRANTY

GALLANT SPECIALTY TIRE

Husky Tire warrants, subject to the terms, conditions and limitations stated herein, Gallant tires to be free from defects in materials and workmanship.

Husky Tire's liability for tires shall be limited to replacement of any defective tire plus any applicable taxes.

1. THE HUSKY TIRE WARRANTY ["Warranty"] applies only to the Original Purchaser of the Gallant tires for 48 months from the date of purchase (proof of purchases required), or if proof of purchase is not available, the coverage will be 48 months from the date of manufacture.

2. The Warranty is void if the tire fails due to damage from improper inflation pressure, exceeding the maximum speed limit, or overloading the tire beyond the maximum load capacity stated on the sidewall.

3. The Warranty does not cover incidental or consequential damages, including, but not limited to, lost time, inconvenience, loss of vehicle use, cost of towing or transportation, related property damage or consequential damages of any type or nature.

4. The Warranty does not cover mounting and balancing charges.

5. The Warranty is void if a tire is worn to the last 2/32" of tread depth at any point on the tread contact surface.

6. The Warranty DOES NOT apply to the following:

- (a). continued use while run flat or under a state of acute under-inflation
- (b). repaired tires
- (c). tires used in racing or competition
- (d). tires subjected to overloading, improper mounting, use of an incorrect rim, purposeful abuse or chemical contamination
- (e). tires which have been patched, plugged or repaired or into which liquid balancers or sealants have been introduced
- (f). cosmetic irregularities
- (g). tires in which a tube has been installed

7. HUSKY TIRE makes no expressed claims of expected tire wear. Variables that affect tire wear are driving conditions, load and tire inflation pressure.

8. The Warranty does not cover road hazard conditions.

To obtain warranty adjustments or warranty information contact the original dealer from which the tire(s) were purchased. Claims must be made within 30 days of discovery of irregularity. HUSKY TIRE reserves the right to inspect all products before making adjustments.

THERE ARE NO WARRANTIES EITHER EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF. HUSKY TIRE SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES. NO REPRESENTATIVE OF HUSKY TIRE HAS AUTHORITY TO MAKE ANY REPRESENTATIONS OR PROMISES EXCEPT AS STATED HEREIN.

Some states do not permit limitations on the period of an implied warranty and do not permit the exclusion or limitation of incidental or consequential damages, therefore the above limitations or exclusions may not apply. This warranty provides specific legal rights. Other rights may vary according to the state/province in which the original purchaser is located.
